EPA Objective

The 1st4sport Level 3 Outdoor Activity Instructor EPA is designed to assess apprentices against the apprenticeship standard, ensuring that they can demonstrate competence in delivering outdoor activity sessions, ensuring participant safety, and promoting engagement with outdoor learning.

EPA Purpose

This EPA validates that apprentices have developed the necessary knowledge, skills, and behaviours to safely plan, deliver, and review outdoor activity sessions. It ensures that apprentices understand risk management, environmental sustainability, and how to support participant engagement through high-quality instruction.



EPA Gateway Requirements

Before entering the End-Point Assessment, apprentices must:

- Complete at least 12 months of training.
- English and Maths requirements:

-Apprentices aged 16 to 18 (or where required by the employer): Achieve Level 2 English and Maths.

-Apprentices with an Education, Health and Care Plan (EHCP) or a Learning Difficulty Assessment (LDA): The minimum requirement is Entry Level 3 in English and Maths instead of Level 1.

• Submit a portfolio of evidence (for the Professional Discussion).

• Employer must confirm the apprentice is ready for EPA.

Once all gateway requirements are met, the two-month EPA period begins.



Practical Test

The practical test assesses the apprentice's ability to plan, deliver, and evaluate an outdoor activity session. It includes a written session plan, a live session observation, and questioning.

• Duration: Three hours (includes session planning, delivery, and questioning).

- Key Areas Assessed:
 - Session planning, including risk assessment and safety measures.
 - Delivering the session effectively, engaging participants.
 - Adapting to environmental changes and participant needs.
 - Managing resources and sustainability considerations.
 - Reflecting on session success and areas for improvement.

Professional Discussion

The professional discussion assesses the apprentice's ability to reflect on their knowledge and practical experience, supported by their portfolio of evidence.

- Duration: 45 minutes.
- Key Topics:
 - Health and safety, and risk management in outdoor activity sessions.
 - Instructional methods and participant engagement techniques.
 - Environmental sustainability in outdoor instruction.
 - Personal reflection and professional development.
