

Unit Aim	The aim of this unit is to provide the learner with the knowledge, skills and understanding required for caring for and preparing the mare for covering in the process of getting the mare in foal. The learner will need to be able to care for the barren mare, confirm the mare's receptivity for covering, prepare the mare for covering, assist with covering, carry out arrangement for pregnancy tests and care for in-foal mares from covering to foaling. The learner will also need to contribute to the organisation of teasing routines, and maintain the safety of the foal throughout.

Explain the checks the vet will undertake within the first 24 hours as part of routine practice"

3.4 Describe the different stages of labour for a mare	Learners will include the three clear stages of foaling, the signs of each stage of labour and the time parameters for each stage
3.5 Describe abnormal presentation and explain when to seek help	Learners will describe different examples of abnormal presentation and when to seek further assistance including but not limited to dog sitting, breech, posterior presentation, and head back.
3.6 Describe the types of abnormal signs of health and behaviour in the mare and newborn foal and the appropriate action to take	Learners will describe different types of abnormal signs of health and behaviour in both the mare and new-born foal and the appropriate action to take for each sign. This will include:  - Abnormal behavioural responses of mare towards the foal -Abnormal behaviour of foal post-partum (ie Maladjustment Syndrome)  -Abnormal physical signs in the mare such as haemorrhage, retained placenta  -Abnormal physical signs in the mare such as haemorrhage, retained placenta  -Abnormal physical signs in the foal such as wry nose, conformational issues, broken ribs  -How to report and manage the above issues once presented
3.7 Explain how to manage the placenta after foaling	Learners will explain why to check the condition of the placenta after foaling and the problems that can present when a placenta is retained This will include: -Healthy and unhealthy placenta appearance referring to colour, texture and shape -The impact and causes of a retained placenta -Treatment of a retained placenta
3.8 Summarise risks during foaling	Learners will summarise risks to horses, self and others during foaling and outline how these can be minimized
