The qualification is designed for those who wish to become involved in badminton as an independent coach, and wish to take responsibility for the ongoing development of participants.

Qualification Progression

Holders of this qualification are able to progress onto the 1st4sport Level 3 Certificate for Head Coaches in Badminton, which is designed to develop in the learner the necessary skills, knowledge and experience to deliver an annual coaching programme to either adults or young people.

The skills and knowledge developed may be used to enable learners to progress to other industryrelevant qualifications in coaching sport, activity leadership, supporting PE in school sport and sports development.

This qualification may lead to paid employment or unpaid voluntary roles in coaching badminton, either working independently or as part of a coaching team. Other roles that the learner may consider exploring include Activity Leader, Official and Sports Volunteer.
