Qualification Objective:	This qualification qualifies learners to understand how to ensure participants' safety and to prepare resources for a netball coaching session.
Qualification Purpose:	Develop knowledge and/or skills in a subject area.

### Who is this qualification for?

This qualification is designed for aspiring netball coaches to be supported in the development of their knowledge of how to effectively coach a local club or school team. It is aimed at those looking to become an assistant netball coach, working under the appropriate supervision of a more qualified netball coach.

### Qualification Progression

This qualification leads to further learning or training in the area of coaching netball and/or other related areas. Learners achieving this qualification might consider progressing on to the 1st4sport Level 2 Certificate in Coaching (Netball) or the 1st4sport Level 2 Certificate in Coaching (Sport and Physical Activity).

This qualification can lead to paid or voluntary roles as an assistant netball coach. Other roles that the learner may consider exploring to include activity leader, netball umpire and sports volunteer.

## Entry Requirements

Learners must be a minimum of 16 years old at registration and 16 years old at certification.

## Pre-requisite(s) or other entry requirements

The recognised centre is required to conduct an initial assessment of learners to ensure that pre-requisites to registration and certification and any barriers that may disadvantage a learner under the Equality Act 2010 are considered and outcomes recorded during the application process.

Prior to registration learners are required to:

- be accurately identified
- be at least 16 years of age
- be able to undertake this assessment in English or Welsh (if available)

## Assessment Methods

The assessment methods used in this qualification are:

- Coursework (in 3 of 3 mandatory units),
- Practical Demonstration/Assignment (in 3 of 3 mandatory units)

Reasonable adjustments can be applied to these assessments in line with 1st4sport Policy Statement: Access Arrangements.

This qualification will be graded Pass / Fail.

- hold the 1st4sport Level 2 Certificate in Coaching Netball or a Level 2 qualification in coaching netball or equivalent as recognised by the NSG for Netball

Tutors are responsible for the delivery of the learning programme developed by England Netball. They must have attended the England Netball qualification induction.

### Assessor(s):

For this qualification, the minimum requirements stated in the centre handbook apply in addition to any further qualification specific requirements stated below

Assessors

The recognised centre is required to recruit and deploy NSG for Netball licensed assessors. The assessor is responsible for the assessment of the qualification. Assessors are required to:

- hold the 1st4sport Level 2 Certificate in Coaching Netball or a Level 2 qualification in coaching netball or equivalent as recognised by the NSG for Netball
- hold or be working towards either:

a recognised teaching qualification or a recognised equivalent, and attended the Netball Assessment Module

or:

the Level 3 Award in Assessing Vocational Related Achievement (QCF), a Level 3 Award in Assessing Competence in the Work Environment or the 1st4sport Introduction to Assessment Practice in Sport (IAPS) or a recognised equivalent

They must have attended the England Netball qualification induction.

### Internal Verifier(s) and Quality Assurer(s):

For this qualification, the minimum requirements stated in the centre handbook apply in addition to further qualification specific requirements stated below

The recognised centre is required to recruit and deploy NSG for Netball licenced IQAs who are responsible for the IQA activities.

IQAs must:

- hold the 1st4sport Level 2 Certificate in Coaching Netball or a Level 2 qualification in coaching netball or equivalent recognised by the NSG for Netball
- hold or be working towards completing the Level 4 Award in the Internal Quality Assurance of Assessment Process and Practice, or the 1st4sport Introduction to Internal Verification Practice in Sport or a recognised equivalent
- hold a Level 3 Award in Assessing Vocational Related Achievement, a Level 3 Award in Assessing Competence in the Work Environment or the 1st4sport Introduction to Assessment Practice in Sport (IAPS) or a recognised equivalent

They must have attended the England Netball qualification induction.

## Additional Qualification Requirements

The minimum venue, facility and requirements stated in the centre handbook apply.

In addition further qualification specific requirements are:

All training and/or assessment sites must include the following facilities and equipment:

- one indoor netball court (minimum confirmed size of four badminton courts, including a full-sized shooting circle of 4.9 m) of uniform construction and even surface.
- a minimum of 10 size 5 netballs
- a minimum of 2 netball posts
- a minimum of two full sets of netball bibs, in two different colours
- 50 flat marker cones

This qualification is regulated by Ofqual (603/2629/3) and QiW (C00/1305/1 - Designated).
